



PabloWhite – Privacy Policy

Effective Date: July 1, 2025

 *This Privacy Policy is governed solely by the laws of the United States of America. Any Spanish translation is provided for convenience only and has no legal effect.*

1. Controller of Personal Data

This platform is developed and operated by **WhiteTech LLC**, a U.S.-based technology company. WhiteTech LLC is the sole controller of all personal data collected through PabloWhite and its associated tools (including integrations with WhatsApp bots).

2. What Information We Collect

During registration and use of PabloWhite, the following personal data may be collected:

- Full name
- Email address
- Tax Identification Number (CUIT or equivalent)
- Access credentials to your local tax authority (e.g., password or digital key), with express consent

Important: By providing your tax ID and login credentials, you expressly authorize PabloWhite to interact with the relevant **tax authority** solely on your behalf and under your direction.

We do not collect or store credit card numbers or banking data unless expressly provided for billing purposes.

3. Purpose of Data Processing

Your data is used to:

- Create your user profile and allow access to the platform
- Issue official tax documents (e.g., invoices) through integrations with your local tax authority, based on your explicit consent
- Generate and store organized records of your fiscal activity
- Communicate with you via email or WhatsApp regarding the use of PabloWhite

WhiteTech LLC does **not assume responsibility for the accuracy, timeliness, or legal compliance of the data submitted by Users or of the resulting documents or declarations.**

4. Use of Tax Credentials – Identity Validation and Liability

By entering your tax identification number and access credentials into PabloWhite and/or its connected tools (e.g., WhatsApp bot), you authorize the platform to access your tax authority's digital system on your behalf.

From that moment:

- All actions performed through PabloWhite (including issuance of tax documents or data synchronization) are considered to have been executed directly by you as the taxpayer.
- PabloWhite acts solely as a technical intermediary and **does not assume the role of a tax representative or authorized filing agent.**
- **WhiteTech LLC is not liable for any misuse, errors, omissions, or failed submissions involving the tax authority**, including missed deadlines or incorrect filings resulting from your use—or non-use—of the platform.

You are solely responsible for:

- Ensuring that your fiscal data is accurate and up to date
 - Reviewing and validating all documents issued through the platform
 - Complying with your local tax regulations and obligations
 - Keeping your credentials confidential and secure

5. Optional Referrals to Tax Professionals

If desired, you may voluntarily request professional assistance through the platform. This redirection may lead you to **Craneando Tax**, an independent brand operated by **Gabriel Hernán Cohen** (CPCEPBA MN 47858/0 T11F60).

Such services are **entirely independent** from PabloWhite. Any professional engagement will be governed by separate terms directly between you and the advisor.

6. Data Retention

Your personal data will be retained for as long as your account is active or as required by applicable law. You may request deletion of your account and associated data at any time.

Note: If you remove access credentials, PabloWhite will no longer be able to perform any operations with the tax authority on your behalf.

7. Security Measures and Disclaimer of Liability

WhiteTech LLC implements reasonable and appropriate technical and organizational safeguards to protect your data against unauthorized access, loss, or misuse.

However, **no digital system is entirely immune to breaches, cyberattacks, or unauthorized access**. By using PabloWhite, you acknowledge and accept the inherent risks of operating in an online environment.

WhiteTech LLC shall not be liable for any damages—direct or indirect—resulting from security incidents, data breaches, or unauthorized access, unless proven to result from gross negligence or willful misconduct.

You are solely responsible for:

- Keeping your login credentials confidential
 - Avoiding access from shared or unsecured devices
 - Reporting any suspicious activity related to your account
 - Ensuring your own security practices comply with best standards
